

## **Where Can PPE Take You?**

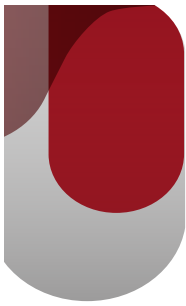

## About the Major

Philosophy, Politics, and Economics (PPE) majors learn to investigate the social phenomena that philosophy, political science, and economics address from different perspectives. Philosophy fosters clear and creative thinking, ethical reflection, and the capacity to interrogate received opinion. Political science offers both theoretical and empirical

approaches to studying governing institutions and political relationships. By studying economics, students learn to analyze the role of incentives, markets, and governments in the allocation of scarce resources and distribution of income.

PPE graduates gain the ability to appreciate the complexity of policy initiatives. Arguably, PPE's multifaceted approach is necessary to adequately evaluate any policy proposal, since such an evaluation demands answers to different kinds of questions: For example, whether the policy is politically feasible, whether it is economically efficient, and whether it is fair and just to everyone involved.
